MONTHLY BOARD OF SUPERVISORS MEETING  
MAY 8, 2012

The monthly meeting was called to order at 7:00 pm and pledge led by chairman Ranweiler. Also present were supervisors Linda McCabe & Steve Box ;Gail Lunde treasurer & Coralea Borden, clerk. Motion Box, second McCabe to approve minutes of April 10, 2012 meeting; all aye; motion carried.

Constituent concerns:

Old Business:

McCabe makes motion to approve Resolution authorizing contract with interested officer for Ranweiler; Box seconds; Ranweiler makes motion to adopt same resolution for Box; McCabe seconds; all aye. Box makes motion to adopt resolution for McCabe; Ranweiler seconds; all aye; motion carried.

Town/Fire Hall Update:

Bruce reports that white pine in cemetery cannot be saved. Board agrees. Bruce to take down soon. Bruce also has noticed that letters on metal stakes in cemetery are falling off. Sandy Harris to check with records at county & funeral home to see if it should be township responsibility to replace.

Ranweiler has bid for cleaning & patching up tennis court from Anderson Brothers. Bid is for just over \$6750.00. Box makes motion to accept bid on tennis court; McCabe makes motion; all aye; motion carried.

Road Report

Annual Road tour was held on April 27. Antler, Old Mill S.& Ossipee need some scraping of sod along sides of road to help with water run off. Board considers this to be routine maintenance & would like Borden Excavating to start work on.

Ranweiler has gotten bid from Anderson Brothers for crack sealing on Rebel & Sorenson for \$2453.80. McCabe makes motion to spend no more than \$2500.00 on crack sealing after Ranweiler accompanies Anderson Brothers on roads to count cracks; Box seconds; all aye; motion carried.

Homestead, Shellum, Lord & Indian Head all need old sod removed, reshaped & class 5. Bid from Borden Excavating for labor is \$21,500. Bid for class 5 from Anderson Brothers is \$15.29 per yard. Fletcher trucking had bid for class 5 at 12.50 per yard. McCabe makes motion to spend balance of Subordinate Tax district funds on Indian head, Shellum, Homestead & Lord. Box seconds; all aye; motion carried. Board would like Coralea to send out letter to property owners on those four roads letting them know of the road improvements to be done.

Beavers are becoming a problem along Rebel road. Township has permission from Mausts to fix problem. Ranweiler has talked to Skip Rudquist & Skip feels that beavers should be trapped before dam & hut are blown. Box Makes motion to spend money to take care of problem before damage is done to road; McCabe seconds; all aye; motion carried.

Ranweiler would like to get bid from Borden to replace signs & posts for township.
