

CENTER TOWNSHIP, CROW WING COUNTY  
MONTHLY BOARD OF SUPERVISORS MEETING  
April 13, 2010

The meeting was called to order and pledge led by chairman Greg Ranweiler at 7:00 pm. Also present was supervisors Terry Ebinger & Linda McCabe; Gail Lunde treasurer & Coralea Borden, clerk. Motion Ebinger, second McCabe, to approve minutes of March 2, 2010 meeting; all aye; motion carried.

Reorganization meeting called to order. Ebinger makes motion to have Ranweiler continue to serve as chair; McCabe seconds; all aye; motion carried.

Constituent concerns:

Old Business:

McCabe makes motion to approve the resolution for keeping of dogs; Ebinger seconds; all aye; motion carried. Supervisors recommend posting at hall & website, also to publish in Dispatch that an ordinance is now in effect.

Town/Fire Hall Update:

Bruce Lunde reports that stumps have been ground in cemetery & playground.

Road Report

Annual road tour is set for Tuesday, April 20 at 7:30am.

8 ft. culverts have been installed on Antler Rd. Purchased from Anderson Brothers & Borden Excavating installed. Coralea to ask Matt to remove old debris from area where new culverts were installed. John McCabe has heard that an old fire truck is for sale for \$6500.00, wondering if township would be interested in purchasing for dust control.

Pre-construction meeting was held at town hall on Monday, April 12 at 2:00. Ranweiler, Jeff Ledine, Anderson Brothers & CTC in attendance. Projected start date of May 10. Jeff Ledine has looked at frost boils on Rebel Rd. Anderson Brothers has no problem if township hauls some class 5 in & grades before construction begins. Jeff Ledine thinks approx. 1400 yards of class 5 will be needed on Rebel.

Ranweiler gave cutoff dates to Anderson Brothers for pay schedule. As our meetings are second Tuesday of the month, bills need to be to clerk one week before monthly meeting..

New Business:

Ranweiler addresses that Steve Wentworth Sr has dropped off letter for Board to review. Ranweiler states that this is the way the board decided to access this Rebel/ Sorenson project. Ebinger agrees with Ranweiler, feels this question has already been answered. Ranweiler states that nothing will change re this upcoming project. McCabe agrees with Ebinger & Ranweiler stating that one will never know what would have happened if project would have been paid for by the entire township, as this was the decision that was made & there is no going back.

McCabe makes motion to approve \$75.00 pay for the moderator at the 2010 annual meeting; Ebinger seconds; all aye; motion carried.

Ranweiler makes motion to pay election judges for their attendance at the annual meetings; McCabe seconds; all aye; motion carried.

Gail wonders if summer picnic should be held on a Saturday, with the supervisors possibly grilling. Ranweiler not sure if he likes the idea of having picnic on Saturday, but does like idea of grilling. Gail to prepare news letter for residents & would like input of supervisors.

Date for summer picnic to be Monday, July 19, 6:00-8:00 pm. Ask residents to bring dish to share. Township to provide brats, burgers, buns & beverages.

Ebinger makes motion to change August monthly meeting to Tuesday, August 17; McCabe seconds; all aye; motion carried.

Coralea to call judges on her list to see if all are still interested in serving as election judges. Let board know at May meeting.
