Matt Borden reports that he has inspected Green Acres Court road & there are several areas that have 3.5 in of class 5, but is good class 5 and would last long time yet. Matt feels this is good class 5 & additional class 5 would not be needed.. Township resolution in the acceptance of roads states minimum 4in class 5. Board feels that they need to stick to this recommendation. McCabe makes motion to have Pines on The Mississippi Association fill in all areas with class 5 to meet township standards before next months hearing; Yeager seconds; all aye; motion carried.

Leon reports that Lake Edward will not rent out their equipment for brushing. Borden to do brushing/limbing work on Gallus, Oakland Parkway & CR 116.
