ANNUAL TOWN MEETING, MARCH 10, 2015, 8:15 PM

The annual meeting was called to order at 8:15 by clerk, Coralea Borden. Pledge was led.

Linda McCabe ; I nominate Tom Borden as moderator; Skip Rudquist; I'll second; unanimous aye.

Minutes of 2014 annual meeting were distributed.

Melonie Flaws; I will make motion to approve 2014 annual meeting minutes; Linda McCabe; I'll second; all aye; motion carried.

General Report: Linda McCabe reports that Steve Box has resigned as of April & board appointed Leon Yeager. Also, Bruce Lunde retired & was replaced by Dan Behmyer. Gail Lunde also retired & has been replaced by Melonie Flaws for a 2 year term.

Road Report: McCabe reports annual road tour was held in April. Road work included class 5 to several roads. Dust control was placed on Borden, Silver & Ossipee. Certified town mileage for 2015 is 21.7 miles. Contract was signed with Borden Excavating Inc. through Feb 2016 at no price increase.

Cemetery Report: McCabe reports that not too much has been happening in cemetery. Reminder to remove all flowers & decorations in timely manner or maintenance person will remove.

Fire Report: Leon Yeager reports that Center town ship had 41 calls last year. All but 5 were medical. Mission has purchased 2 new fire trucks last year. They have received a \$25,000 FEMA grant that has helped purchase new equipment.

Proposed levy is discussed and board has proposed a \$8,000 increase in the levy from last year to bring the total levy request to \$228,000. Melonie Flaws; I make motion to approve proposed levy for 2016; Dan Behmyer; I second; all aye; motion carried.

Kathy Linzbach ; I make motion to spend up to \$300.00 on township picnic; Melonie Flaws; I second; all aye; motion carried. Borden reports that Board of

Canvass met prior to meeting to certify election results; votes are as follows; Greg Ranweiler, supervisor 26 votes; Leon Yeager supervisor 26 votes; Melonie Flaws, Treasurer 26 votes.
