MONTHLY BOARD OF SUPERVISORS MEETING  
JUNE 12, 2012

The monthly meeting was called to order at 7:00 pm and pledge led by chairman Ranweiler. Also present were supervisors Linda McCabe & Steve Box ; Gail Lunde treasurer & Coralea Borden, clerk. Motion Box, second McCabe to approve minutes of May 8, 2012 meeting; all aye; motion carried.

Constituent concerns:

Bernie Winkleman in attendance & has a 15 acre parcel in Center township & currently owns this land with a friend. He would like to just split the parcel into two 7.5 acre lots. Board sees no problem with this & will sign all paper work for Crow Wing County. McCabe makes motion to approve papers; Box seconds; all aye; motion carried.

Old Business:

Town/Fire Hall Update:

Bruce states that there was a lot of flower & decorations left at cemetery from Memorial weekend & would like to remind people to either pick up decorations or they will have to be disposed of after 2 weeks. Bruce also has concerns of some people using weed killer at cemetery around stones. Board would like Sandy Harris to write letter to family explaining not to do this. Road Report

Ranweiler reports that road work on all 4 roads has been completed & looks good. Anderson Brothers has hauled class 5 & will get billed soon. Price has come in under bid.

Matt Borden in attendance & explains situation with beavers on Rebel & Sorenson. Borden concerned about water level along Rebel. Water level is only 6 inches below road now. Ranweiler will take a look at soon.

Borden gives bid for putting up signs up for township at \$50.00 per sign. Box makes motion to give Matt permission to put up signs at cost of 50.00 per sign: Box seconds; all aye; motion carried.

Ranweiler had gotten bid from Anderson Brothers for crack sealing at almost \$2500.00. Anderson Brothers had given Ranweiler the wrong estimate. Correct estimate for crack filling on Rebel & Sorenson is \$5542.00.

Ranweiler has taken a look at cracks & feels that it could wait another year. McCabe & Box agree.

Summer picnic to be held on Monday August 20, from 5:00- 7:00pm. Board will grill hot dogs & burgers once again this year.

August monthly meeting needs to be rescheduled due to primary election. McCabe makes motion to have Aug. monthly meeting on Tuesday August 7 instead of 14<sup>th</sup>; Box seconds; all aye; motion carried.

McCabe makes motion to approve all 12 election judges for training on 7/17 & 4 head judges for 7/25. Judges are as follows: Mary Petersen, Gail Lunde, Linda McCabe, Jenel Boller, Joyce Ranweiler, Sandy Harris, Cathy Linzbach, Joan Sanford, Nancy Ebinger, Beki Sommer, Sandy Riess, & Coralea Borden. Head judges; Sandy Harris, Gail Lunde, Mary Petersen, & Coralea Borden.

McCabe would like to get some new play ground equipment. Ranweiler & Box agree. Ranweiler could possibly see spending \$2000-\$3000 per year to have a nice play are at the hall. Ranweiler to check into this and Gail to mention in news letter.

Ranweiler has talked to George from Lake Edward township & trouble some tree on corner of Rebel & Sorenson has been trimmed up so it is no longer such a danger.
