MONTHLY BOARD OF SUPERVISORS MEETING
August 13, 2013

The monthly meeting was called to order at 7:00 pm and pledge led by chairman Ranweiler. Also present was supervisor Linda McCabe; Gail Lunde treasurer & Coralea Borden, clerk. Supervisor Steve Box was absent for August meeting. Motion McCabe to approve minutes of July 9, 2013 meeting; Ranweiler seconds; all aye; motion carried.

Old Business:

Town/Fire Hall Update:

Bruce Lunde reports that there is a white pine out at the cemetery that is slowly dying. Ranweiler to call Mikes Tree Service to get price to take down & grind stump. McCabe makes motion to have Mikes Tree Service take down white pine in cemetery & trim trees in back if price is reasonable: Ranweiler seconds; all aye; motion carried.

Road Report

Greg attended meeting at CWC Hwy Dept. Basics of meeting was to discuss future partnership of townships & Crow Wing County. Ranweiler has received bid from Borden Excavating for proposed road work from July meeting. Old Mill would require approx. 4 in of class 5 from Anderson Brothers. Borden estimates labor for Old Mill at 6800.00. Blue Bonnet would require ditching, scraping, class 5 at a price of 3500.00. Sorenson, Indian Head & Rebel all need trees taken down as they are dying & leaning over the road. Letters may need to be sent out to a few property owners for permission to take down. Ranweiler would like to have dust control on Borden for next year. South side of Riley road needs scraped & class 5 added. Letter to be sent out to residents on Silver Lake road regarding possible widening & ditching of road. Ranweiler makes motion to proceed with proposed road work, Old Mill at price of \$28,500, Blue Bonnet at \$14,000. Riley at \$2500.00. Spring of 2014 work to include class 5 on Borden Rd & dust control; McCabe seconds; all aye; motion carried. Matt & Greg to drive Silver lake road sometime in near future to discuss proposed work.

Water pump at old hall has recently tested positive for E-coli. Bruce to bleach well in a couple of weeks.
