#### Old Business:

Ranweiler makes motion to put following amounts in each bank American National-\$249,000 chk # 10248; Lakewood Bank \$249,000 ck # 10249, Riverwood Bank \$200,000 ck # 10250 & Deerwood Bank \$100,000 ck #10251 leave the rest in Bremer. McCabe seconds; all aye; motion carried.

Ranweiler has discussed buying a sanding truck with Borden Excavating. Matt to keep his eye out for trucks. Matt thought that \$15,000 would buy a nice truck with a plow. Roads are icy now & Holmvig is our only option for sanding roads. Ranweiler to contact Holmvig.
