

CENTER TOWNSHIP, CROW WING COUNTY
MONTHLY BOARD OF SUPERVISORS MEETING
JUNE 9, 2015

The monthly meeting was called to order at 7:00 pm and pledge led by chairman Ranweiler; Supervisors McCabe and Yeager; also in attendance and Melonie Flaws ;treasurer & Coralea Borden, clerk. Yeager makes motion to approve meeting minutes from May 12, 2015; McCabe seconds; all aye; motion carried. Make note to change minutes from interior light change to exterior.

Constituent concerns

Twyla Flaws in attendance & explains that a possible plugged culvert on west side of Rebel road is causing her driveway/yard to be flooded for the last 4 years. Ranweiler would like to meet up with Borden & take a look. Jean Lingren who resides on Ossipee rd in attendance & is having some issues with the poor condition of road at the end of his driveway. Jean would like to know if paving Ossipee is in a long term plan. Ranweiler explains that there is no plan to black top the road. Approx 3 inches of class 5 was added to Ossipee last year. Borden explains that only remedy would be to scrape all class 5 off & dig out to repair.

Old Business:

Town/Fire Hall Update:

Dan reports that mowing is going well & he has placed tennis nets up.

Road Report:

Ranweiler & Borden have checked class 5 quantities- Antler road would need shaping, ditching, 600 yards class 5 at a price of \$13,150.00, Blue Bonnet- class 5 of south end- 400 yards with labor \$8100.00, Homestead rd class 5 500 yards & shaping \$10,125, Lord road 500 yd & shaping \$10,125, Old Mill North- ditching, class 5 \$23,800. Class 5 would be delivered from Anderson Brothers at a price of \$15.25 per yard. Price for each road includes class 5 & shaping from Borden Excavating. McCabe makes motion to do all 5 roads for a total price of \$65,300; Yeager seconds; all aye; motion carried.

Dust control from Tri-City is 91.9 cents per gallon, 18 ft wide per mile is \$2426.00. Yeager makes motion to have dust control applied on Ossipee, Old Mill South, Borden & Silver Lake roads; McCabe seconds; all aye; motion carried. Additional roads to be considered at during the July monthly meeting.

Dip in road on CR 116 needs repair. Ranweiler has talked to AB regarding this. Estimate to fix would be \$ 600-\$700. Green Forest Circle has a basketball size hole under the asphalt & also needs to be addressed. Shouldering & brushing needs to be done on Sorenson Lake Rd at approx \$1500.00.

New Business:

Four new permits were issued in township for the last month.

Treasurers Report/ Check Approval .

Yeager makes motion to approve check numbers 11637-11659 in the amount of \$28,635.87 McCabe seconds; all aye; motion carried. McCabe makes motion to approve treasurer report; Yeager seconds; all aye; motion carried. Yeager moves to adjourn McCabe seconds; all aye. Meeting adjourned at 7:50pm
