March 2, 2010

Old Business:

Ranweiler has talked to electrician re off peak. Heater we already have is sufficient. Borden Excavating cost to install beaver pond leveler would be anywhere from \$600.00- \$1000.00. Cost of leveler itself would be around \$800.00. Board agrees to have Matt unplug culvert & assess situation at that time.

Ranweiler makes motion to approve Bacon Davis wages for Road project; McCabe seconds; all aye; motion carried.

Ranweiler makes motion to approve hourly contract for engineers for Road project; McCabe seconds; all aye; motion carried.

McCabe makes motion to authorize Ranweiler to sign additional documents for Bonding company after approved by Tom Borden; Ebinger seconds; all aye; motion carried.

McCabe makes motion to have 2010 rd tour on Tuesday April 20th at 7:30 am; Ebinger seconds; all aye; motion carried.

New Business:

Linda voices her concern on issue of Board of Canvass meeting after the 2 day deadline. Linda not pleased that she will be the only supervisor attending the annual meeting. Urges Ranweiler & Ebinger to be present at next years annual meeting. Ranweiler to prepare road report for annual meeting.

Gail needs about \$167.00 worth of updating for her computer. Ebinger makes motion to approve updates; McCabe seconds; all aye; motion carried.

McCabe makes motion to approve new animal control contract for period of March 30 2010- March 30 2011

Ebinger to call Central Applicators to set up weed control for summer.

Ebinger resigns effective as of now for the duration of his term. Ranweiler makes motion to accept Terry's resignation with regrets. McCabe seconds; all aye; motion carried. McCabe makes motion to appoint Gerome Petersen to fulfill Ebingers term; Ranweiler seconds; motion carried.
