

CENTER TOWNSHIP, CROW WING COUNTY  
ANNUAL MEETING, MARCH 13, 2012

The meeting was called to order at 8:15 pm by acting clerk Linda McCabe. Pledge was said. Motion Tom Borden: "I move that Warren Herold serve as moderator.; Curt Wohl: "I second"; all aye; carried.

Motion Tom Borden: "I move to approve the minutes of the March 8, 2011, annual meeting."; Mary Petersen: "I second."; all aye; carried.

Motion Warren Herold: "I move to have meeting agendas on the township's website."; Mary Petersen: "I second."; all aye; carried.

McCabe gave the General report. Small snowblower and estate rake purchased. Black dirt and seed spread at hall. Class 5 spread at east side of hall. Bruce Lunde did an inventory of equipment and furnishings for insurance purposes. Motion Sandy Harris "I move to approve the general report."; Kathy Linzbach: "I second."; all aye; carried.

Wohl would like some of the trees on the south side of Blue Bonnet Road removed due to poor visibility; it will be added to the road tour.

Box gave the Road report. Old Mill N. from CR 116 to Ossipee Rd. was widened, ditched & raised. Blue Bonnet Rd. was realigned & moved south with some ditch work done along the property of Curt Wohl. Beaver problems were again an issue on Sorenson Lk Rd & Antler. Motion Curt Wohl: "I move to approve the road report."; Mary Petersen: "I second."; all aye; carried.

McCabe gave Cemetery report. Lunde continues to do great maintenance. New split-rail fence will be installed this summer. Motion Steve Box: "I move to approve the cemetery report."; Curt Wohl: "I second."; all aye; carried.

Box gave the Fire report. Total calls for Mission Fire Dept. in 2011 was 79. That number is down 10% from last year. Center township made up for 32 of those calls. Joe Ashman, assistant fire chief, gave a more in-depth report of the activities of the Mission Fire Department over the past year and explained the Firewise program that may be starting this summer and the Vial of Life. Motion Linda McCabe "I move to approve the fire report."; Mary Petersen: "I second."; all aye; carried.

Financial report. Motion Linda McCabe: "I move to approve the 2011 financial report as distributed."; Tom Borden: "I second."; all aye; carried.

2013 levy: Discussed, but will not be approved until later after the legislature adjourns and it is known whether we will have an unallotment from the legislature, and if so, how much.

McCabe reported that the Board of Canvass met just prior to the meeting and certified the election results: Greg Ranweiler, supervisor, 18 votes of 19 cast; Coralea Borden, clerk, 19 votes of 19 cast. Motion Mary Petersen: "I move to reconvene the annual meeting at a date to be determined, prior to September 1, 2012."; Steve Box: "I second."; all aye; carried.
