

**CENTER TOWNSHIP, CROW WING COUNTY
MONTHLY BOARD OF SUPERVISORS MEETING
May 11, 2010**

The meeting was called to order and pledge led by chairman Greg Ranweiler at 7:00 pm. Also present was supervisors Terry Ebinger & Linda McCabe; Gail Lunde treasurer & Coralea Borden, clerk. Motion McCabe, second Ebinger, to approve minutes of April 13, 2010 meeting; all aye; motion carried.

Constituent concerns:

Resident Mike Bjornson in attendance & has neighbor who has a wood burner right on property line & cannot open his window because the smoke is so bad. Ranweiler to talk to Doug Houge re this.

Old Business:

McCabe makes motion to approve training for all election judges on roster, Ebinger seconds; all aye; motion carried.

Town/Fire Hall Update:

Bruce Lunde reports that old rusty flag pole at cemetery is in the way of mowing & an eye sore. Ranweiler & Ebinger feel that a new pole should be installed. A flag should be flown on Memorial day & Independence day.

Lunde has started to mow at cemetery. Board would like a fertilizer with weed killer spread on grass at hall & cemetery.

Road Report

Road tour was held on April 20. South end of Blue Bonnet needs a corner reshaped & the taconite gravel needs to be removed. (Approx 176 yards). & to be replaced with class 5. No trees will be removed. Take 4 in. off Blue Bonnet & place on Old mill for \$2500.00. Place an additional 250 yards of fill & replace culvert & bring in 352 yards of fill of class 5 for \$6,000.00. 821 yards of class 5 for Borden rd. \$4722.00. Ranweiler makes motion to approve Borden Excavating to do work on township roads; McCabe seconds; all aye; motion carried.

New culverts are being placed on Sorenson/ Rebel project. Rain has delayed start date of black top.

Ebinger feels that new grader operator has not been doing a good job lately. Has been taking crown off of roads. Ranweiler to discuss this with Matt.

Jeff Ledine in attendance & feels that township should order road restriction signs to be posted for next spring. 3 signs to be ordered.

New Business:

McCabe makes motion to approve Gail to attend PERA training in June. Ebinger seconds; all aye; motion carried.

Gail reports that checking account interest is so low right now that strictly using the money market with a higher interest rate may be a good idea. Gail will look further into this matter.
