MONTHLY BOARD OF SUPERVISORS MEETING
May 12, 2014

The monthly meeting was called to order at 7:00 pm and pledge led by chairman Ranweiler.; also in attendance was Supervisor Linda McCabe; Gail Lunde treasurer & Coralea Borden, clerk. Motion Ranweiler to approve minutes of April 8, 2014 meeting; McCabe seconds; all aye; motion carried.

Constituent concerns

Owner from Grandpa's General Store present & requesting renewal of off sale 3.2 liquor license. McCabe makes motion for renewal; Ranweiler seconds all aye motion carried.

Old Business:

Board would like to appoint new supervisor to take Steve Box's position. McCabe makes motion for Leon Yeager to fulfill Box's position; Ranweiler seconds; all aye; motion carried. Oath given to Yeager.

Town/Fire Hall Update:

Bruce Lunde reports that one of the pressure tanks in mechanical room had a leak. He has since had it fixed by Horizon heating & plumbing. Horizon suggested that heating system may not be working properly. Board agrees that system needs to be checked out. Bruce to call & schedule appointment.

McCabe makes motion to have pump at old hall abandoned as long as price does not exceed \$1000.00; Ranweiler seconds; all aye; motion carried.

Road Report:

Scott Lembke owns parcel that can only be accessed by river & is currently included in the Rebel/ Sorenson subordinate service district & is charged \$122.00 per year. McCabe makes motion to not have Lembke on 2015 tax assessment roll; Ranweiler seconds; all aye; motion carried.

Annual road tour was conducted on April 22. Antler, Borden, Creek, Gallus, Ossipee & Old Mill south all require class 5. Gallus needs some widening in spots. Ranweiler to discuss price with Borden. Ranweiler will also check water truck for dust control with Mission township at next week's fire meeting.
