Steve Gilbert in attendance he owns property in Homestead development & feels misled by final assessment & unsure of cost & when payment is due. Jeff Ledin explains cost & that payment will be due when property taxes are due. Steve to discuss further with Rod Converse. McCabe makes motion to adjourn assessment hearing; Box seconds; all aye; motion carried.
