Ranweiler & Ledin recently traveled Rebel & Sorenson roads. Beginning of Sorenson has a high bank that needs fixing & other areas need some extra class 5 added. Dip in road near Buckhorn trail also needs to be fixed. Ledin has discussed these problems with Anderson Brothers & they will repair next week. Ranweiler hopes dip will not be a problem next summer.

Jeff Ledin explains that two resolutions need to be passed tonight. Resolution to approve cost for Settler & Buckhorn Trail. McCabe makes motion to accept resolution; Box seconds; all aye; motion carried. Second resolution is to set public hearing date & gives permission to prepare assessment roll & mail out to property owners of Converse development. McCabe makes motion to accept resolution number 2; Box seconds; all aye; motion carried.
