

CENTER TOWNSHIP, CROW WING COUNTY
MONTHLY BOARD OF SUPERVISORS MEETING
June 14, 2011

The monthly meeting was called to order and pledge led by chairman Greg Ranweiler at 7:00 pm. Also present was supervisors Steve Box and Linda McCabe.; Gail Lunde treasurer & Coralea Borden, clerk. Motion Box, second McCabe to approve minutes of May 10, 2011; all aye.

Constituent concerns:

Old Business:

Town/Fire Hall Update:

Bruce Lunde reports he has checked on fencing for cemetery & cost for something similar would be \$1400.00- \$1500.00. Box makes motion to replace fence with new split rail fence & stain; McCabe seconds; all aye; motion carried. Bruce to check prices & make purchase when on sale.

Bruce also reports that a refund from mower was received from a faulty part for \$21.84.

A tree in the cemetery has died & Bruce has contacted Landsburg & they will give a fifty percent discount on new tree. Board gives him go ahead to do so.

Ranweiler makes motion to allow Mission fire dept to purchase a key pad for fire hall door; Box seconds; all aye; motion carried.

Bruce would like to place class 5 around east side of hall to prevent tailings on grass in the spring from snow plowing. Board feels this is good idea.

Road Report

McCabe makes motion to pass resolution regarding Center Townships involvement in purchasing regulatory signs through the county; Box seconds; all aye; motion carried.

Ranweiler to go out on regulatory sign inventory next week.

Board approves of letter to send out to Old Mill Rd North residents.

Ranweiler explains that Borden Excavating is working on bids for road projects & will get them to board soon.

McCabe explains that culvert is plugged again on Antler. Ranweiler to contact Matt re installing Clemson level. Mncore is company that carries them.

New Business:

Kurt Wohl in attendance & explains that he would like to get the portion of his property back that is being used for the road way on Blue Bonnet. He would like to see this portion cleaned up & trees along the road way removed. Kurt has had it surveyed & property line is way off. Explains that at least 25 trees should be removed & ditching done. Box would like to go out & take a look at the property & see exactly where the stakes are Ranweiler & McCabe agree. This issue to be discussed further at the July monthly meeting after the supervisors have looked at it.
