The monthly meeting was called to order and pledge led by supervisor Linda McCabe at 7:00 pm. Also present was supervisor Steve Box. Chairman Ranweiler was absent from October monthly meeting. Gail Lunde treasurer & Coralea Borden, clerk. Motion McCabe, second Box to approve minutes of September 13, 2011 meeting; all aye; motion carried.

Ron Zech shares concern over missing Campbell Lake Rd sign. Campbell Lake Rd is a private drive. Coralea to call Hwy Dept & check into process of ordering new one.

Old Business:

Town/Fire Hall Update:

Bruce Lunde reports that one of the garage doors is not working properly. Talked to a Mission fire fighter & he was going to mention it at their meeting tonight. Bruce would also like to purchase a leaf mulching kit for about \$90.00. McCabe makes motion to purchase kit; Box seconds; motion carried; all aye. Bruce would also like to buy more grass seed for hall & cemetery. Bruce will also purchase a recycling bin for the hall. Pine needles have been an issue at the hall. The pull behind rake is not working well. Bruce has found an estate rake that he has heard would work well. Sells for around \$400.00. He would like to rent one first to see how well it works. Rental cost for the estate rake for 24 hrs is \$25.00. McCabe makes motion for Bruce to rent equipment for a day & if works well to go ahead & purchase one for \$400.00; Box seconds; all aye; motion carried. Bruce would also like to replace the chair rack in hall with a double tier rack that holds 84 chairs. They sell for around \$450.00. Box makes motion to order a double tier chair rack; McCabe seconds; all aye; motion carried. McCabe would like Bruce to also look at some dividers for hall.
