Dave Anderson from Mission township will send out 2012 & 2013 fire contracts with the payment being the same as in 2011. 2014 fire contract will also be sent out at this time, but there will be a rate increase of \$2,250 for that year.

Road Report

Ranweiler states that Borden Excavating Inc. contract is up for possible renewal. Borden Excavating is currently receiving \$78.50 per hr for grading & snow plowing he is asking for \$84.50 per hr. Ranweiler feels this is reasonable, has gotten quotes from other contractors in the past & Borden is still under bidding them.

Ranweiler makes motion to approve new contract for Borden Excavating; McCabe seconds; all aye; motion carried.

New Business:

Board agrees that a levy should be presented at the annual meeting- numbers proposed are as follows: fund 100- \$45,000, 201- \$84,000- 225 \$46,000- 235 \$3,000- 401 \$24,000- 406 \$22,000- For a total proposed levy of \$224,000 a \$4,000 increase from the last several years.

McCabe makes motion to submit proposed levy to constituents at annual meeting; Box seconds; all aye; motion carried.
